

Thank you for your letter dated 10 June 2025 regarding the United Wambo Voluntary Planning Agreement (VPA) Community Committee's request for funding for footpaths and tree plantings in Jerrys Plains.

The NSW Government allocated funding to the first stage of the Port 2 REZ (P2R) program for road infrastructure upgrades from the Port of Newcastle to the Central-West Orana REZ, referred to as the Port to REZ route.

Upgrades as part of the program may include road safety improvements such as new asphalt where road condition is poor, or the creation of designated turning lanes.

We acknowledge the concerns of the Jerrys Plains community in relation to pedestrian safety, however, new footpaths and tree plantings are outside the program's budget and scope.

Adding new components to the work also presents delivery and contractual challenges as construction is underway. The Jerrys Plains design does, however, contain sufficient space to accommodate improvements such as these in the future, should Singleton Council choose to pursue them.

We value the aspirations of the Jerrys Plains community and support Council's longer-term vision for local improvements. While we are unable to fund these improvements as part of the P2R program, EnergyCo remains committed to working collaboratively with Council on project interfaces and other possible complementary initiatives.

REQUEST FOR CONSIDERATION OF FINANCIAL CONTRIBUTION TOWARDS FOOTPATHS IN JERRYS PLAINS

One of the initial discussion items at the commencement of Council's collaboration with EnergyCo. and Transport for NSW on the Port to REZ project was with regards to the United Wambo Voluntary Planning Agreement (VPA). One of the projects identified under the VPA was streetscape improvements in Jerrys Plains, including the construction of footpaths and tree planting.

At that time, (early 2024) the VPA Committee resolved not to proceed with the streetscape project, instead prioritising the allocation of the remaining VPA funds toward other initiatives, primarily upgrades to the Jerrys Plains Recreation Ground.

While enhancements to the Recreation Ground remain the committee's primary focus, there is now also a desire to progress the installation of footpaths in the village. The current priorities identified by the VPA Committee are:

Priority 1 – Construction of a footpath along Doyle Street (between Wambo Street and Jerrys Plains Public School), and

Priority 2 - Construction of footpaths along the Golden Highway.

At the Council Meeting held on the 15 April 2025, Singleton Council endorsed the recommendation made by the United Wambo VPA Community Committee, on the 13 February 2025, that a financial contribution to footpaths in Jerrys Plains be considered as part of the Port to REZ Project

The United Wambo VPA Community Committee raised concerns on behalf of the Jerrys Plains Community on the impacts that the Port to REZ Project will have on the community. Pedestrian safety is a significant concern of the community due to the

- Members must have regard for community needs and ensure proposals for VPA projects provide material public benefit.
- The alternate community representative does not have voting rights unless a community representative is absent from a meeting requiring a committee vote.

Who should apply?

Jerrys Plains and Warkworth community members of all ages, skills and experience, interests and personal circumstances are encouraged to apply. You are not required to be a homeowner in the area to join the Committee, you do however need to be a member of the community. This is it a great opportunity for you to be involved and contribute to decision making that affects your community.
